Objectives and main contents

General objective: to help fill the lack of theoretical knowledge and technical skills of advocacy professionals and antiracist activists of civil society necessary to promote sound, coherent and influential policy advocacy actions by public decision-makers.

Specific objectives:

- To share some strategic approaches to improve advocacy initiatives

- To share the operational steps and technical tools to build strong, effective, and sustainable Policy Advocacy initiatives.

Expected training results:

Participants should better their knowledge and technical skills on advocacy and policy advocacy. They should know:

- what advocacy is
- the main useful sources to be used to support a robust context analysis
- the main steps of the advocacy cycle

- some examples of policy advocacy promoted by migrants and antiracist movements/organizations.

Direct beneficiaries of the <u>pilot</u> training in Rome: 25 antiracist activists and CSO's professionals of partner organizations.

Methodology

Non-formal education to facilitate the active participation and interaction of/between participants.

Language

The training will be held in English in order to enable all four countries' participants to take active part in the sessions.

Training sessions

- 4th June 2022 Morning: Welcome and introductory session Session 1. What is advocacy?
- 4th June 2022 Afternoon Session 2. The advocacy cycle (or Acting step by step)
- 5th June 2022 Morning Session 3 The context analysis
- 5th June 2022 Afternoon Session 4 What must be changed and who has the power to make the change?
- 6th June Morning Session 5 Participation and Networking
- 6th June Afternoon Session 6 A strategic approach to advocacy
- 7th June Morning Session 7 Step by step: Building an advocacy plan
- 7th June Afternoon Session 7 Step by step: Building an advocacy plan (prosecution)
- 8th June Morning Session 8. Final session. Collecting and sharing the training results

Deadline for applications: 20 May 2022

VENUE: The training will be held in the Roma Scout Center, in the center of Rome.

ROMA SCOUT CENTER Via Largo dello Scautismo, 1, 00162, Rome

ACCOMMODATION: You will be hosted in the same place of the meeting, in Roma Scout Center. The Roma Scout Center is known for his serene, friendly and comfortable atmosphere. Moreover, this hostel is situated very close to the city center. You will be accommodated in shared rooms of three or four beds.







Meals

Breakfast and lunch: they will be provided in the hotel.

Dinner. Collective dinners are planned on June 4th and on June 7th.

Participants will be free to organize their dinner on June 5th, 6th and 8th. The maximum available budget for free dinner is **20 euro** for each participant. The expenses will be reimbursed by Lunaria to partners after receiving all receipts.

HOW TO GET TO ROMA SCOUT CENTER?

From Fiumicino to Termini or Tiburtina train station:

There are trains and shuttles to reach Termini Station or Tiburtina Station (only with train) Shuttles: T.A.M, Bus Shuttle, Terravision Shuttles - 7€ Train: Suburban train – 8€ or Leonardo Express- 14€ http://www.trenitalia.com

From Ciampino Airport to Termini:

Shuttles: T.A.M, Bus Shuttle, Terravision Shuttles – 7€

From Termini station to Roma Scout Center:

Take the metro B (ticket cost € 1.50, valid 100 minutes) and get off at the Bologna stop.

Continue for 450 meters by foot on *Viale delle Province* and turn left into *Via di S. Ippolito*. The center is a little further on the right



From Tiburtina station to Roma Scout Center: It is only 750m walk. Leaving the station you have to walk to the bus station, continue towards *Largo Guido Mazzoni*, turn right into *Via Matilde di Canossa*, after 65m turn left into *Via Adalberto* (travel for 280m), and finally turn left again into *Via di S Hippolytus*.



Covid regulation notice:

In order to enter the country, you will either need:

a- Complete vaccination with EMA-authorized vaccine, performed less than 9 months ago (EU Digital Certification or equivalent certification for Italian authorities).

b-Full vaccination with EMA-authorized vaccine and booster dose, in EU Digital Certification format or equivalent certification for Italian authorities.

c-Healing from COVID-19, since less than 6 months (EU Digital Certification format or equivalent certification for Italian authorities).

d-Negative result of molecular swab test conducted within seventy-two (72) hours prior to entry into Italy or antigenic swab test conducted within forty-eight (48) hours prior to entry into Italy.

Moreover, you will have to fill the (<u>digital Passenger Locator Form</u> o dPLF). Remember also to check the Covid policy of the airline you will be traveling with.

For your stay in Italy:

- the Roma Scout Center requires its guests to have a super **Green Pass (COVID-19 Green Certification** for vaccination or recovery) to use its spaces.
- until the end of April, you will need the basic Green Pass (COVID-19 Green Certification for vaccination, recovery, rapid or molecular antigen test with negative result) only to eat or stay inside restaurants, bars, cinemas. In other public spaces the obligation to show the certification has been lifted, but you will however need to wear a protective face mask (FFP2 mask on public transport).
